

A Brief History of Disability Greek and Roman Eras

- Due to the belief of the unity of the body and soul, Greeks often had a negative attitude toward people with disabilities
- Like the Greeks, Romans would legally kill "puny or deformed" children
- Attitudes were also influenced by mythology, and social class



A Brief History of Disability Middle Ages

- Disability was often seen as God's Punishment
- Mental illness was viewed as possession by evil
- Monks and Priests often treated individuals with disabilities and mental illness, rather than physicians, due to the believed religious nature of the illness



A Brief History of Disability: Disability in Early America

- Self-sufficiency was important, the Laws in the 13 Colonies excluded individuals who could not support themselves
- Disability viewed as "God's Punishment"
- Treatment of mental illness based on socioeconomic status, and nature of the illness
- Eugenics
- "Refrigerator Moms"

Disability and Higher Education

- Started in late 1960s in response to Disability Rights Movement. Development of Specialized Campus Offices.
- Initially focused on physical disabilities
- 1980s and 1990s Services Expanded to Attention Disabilities and Learning Disabilities





Disability and Higher Education

- Americans with Disabilities Act and 2008
- 2008 Amendments
- Expansion of Services to Students with Mental Health Diagnosis
- Compliance Model rather than Inclusive Model





Why Students With Disabilities Don't Use Accommodations

- Desire to be self sufficient
 - See accommodations as a back up
- Desire to avoid negative social reactions
- Insufficient knowledge
 of accommodations

- Negative experience
 with faculty and staff
- Fear of future ramifications
- Financial Access to Proper Assessment
- Power Differential



Ableism

- Ableism Perceived form of discrimination or social prejudice against people with disabilities. In ableist societies, people with disabilities are viewed as less valuable, or even seen as expendable. Can impact persons with overt and hidden disabilities differently.

Ableism and How It Rears Its Ugly Head

- "How do we know that person really has a disability?"
- "That accommodation will be expensive. How many people will need that anyway?"
- "That person inspires me every day . They are so brave."
- "You just need to work harder."
- "Just snap out of it."

- "You don't look like you have a disability."
- "It's not fair to the other students/employees if that student gets extra time."
- "Since they have a disability, I'll make sure they get an A in the class."
- "This person has strange behaviors. Are they dangerous?"
- "I broke my leg once and now I understand what it is like to have a disability."
